

2023 Emergency Services Developer -Contractor Impact Fee Schedule

Residential Impact Fees

The Frederick-Firestone Fire Protection District Impact Fee Schedule is effective beginning June 1, 2023. Residential fees are determined based on building type to include Single Family and Multifamily. The Impact Fee shall be paid before the building permit is issued by the Town of Frederick of the Town of Firestone. The District will provide a receipt of payment to the developer and the associated Town.

Residential Impact Fee Schedule

Unit Type	Fee Per Dwelling Unit
Single Family	\$974
Multifamily	\$825

Nonresidential Impact Fees

The Frederick-Firestone Fire Protection District Nonresidential Impact Fee Schedule includes commercial and industrial. The nonresidential impact fee schedule will be implemented June 1, 2023. Nonresidential impact fees are calculated per square foot. The Impact Fee shall be paid before the building permit is issued by the Town of Frederick of the Town of Firestone. The District will provide a receipt of payment to the developer and the associated Town.

Nonresidential (Commercial, Industrial, etc.) Impact Fee Schedule

Fee Per Square Foot \$0.81	

No individual landowner is required to provide any site-specific dedication or improvement to meet the same need for capital facilities for which an impact fee is imposed pursuant to this schedule.

The developer must submit this signed Impact Fee Form with the other documentation required by the Town as part of its development permit application process. If the Town denies the application, the developer is not required to pay the Impact Fee or make an In-Kind Contribution to the District. If the Town grants the application and issues a development permit, the developer must pay the Impact Fee and/or make the In-Kind Contribution or enter into a written agreement with the District before the Town will issue a building permit in connection with the development.
